

SPIRIT LAKES MUSKY TOURNAMENT

RULES

September 17, 2016

Official Entry and Waiver Form

- 1: One team per boat, two anglers per team.
- 2: Fee: \$100.00 per team.
- 3: Pre-registration is required.
Registration are requested prior to September 7, 2016
Late registrations must pay \$150.00 late fee.
- 4: Kickoff meeting will be at 6:30 AM at the boat landing shelter.
At least one representative from each team must be present.
At the meeting teams will be given their numbered flags. Numbers are based on order of registration receipt. This flag will be used to identify the contestants and notify the spotters of a catch.
- 5: Fishing will begin at 7:00 AM. The contest will begin with a shotgun start. Tournament officials may opt for an ease out start, in order of the flag numbers, in case of inclement weather.
- 6: Fishing ends precisely at 2:00 PM. NO EXCEPTIONS.
- 7: All contestants must have a net capable of holding a musky in the water until the spotter boat tells them otherwise. When a musky is caught the fish must be kept in the water until the spotter boat staff arrives and directs the team to present the fish for measuring. The spotter boat staff will do all measuring of fish. The spotters will tell the contestants when to return to fishing.
- 8: The contestants must keep the fish alive.
Should a fish die the team member who caught that fish is finished fishing for the day. He/she may assist his/her partner in netting activities.
- 9: Docking will only be allowed at the public boat landing on Little Spirit NO EXCEPTIONS.
- 10: No live or dead bait is permitted. ARTIFICIAL ONLY
- 11: Only one line permitted in the water at a time for each participant.
- 12: Only registered contestants may fish or help fish.
- 13: At no time are any two contestants boats allowed within 100 feet of each other without mutual consent of both teams.
- 14: All contestants must abide by all state of Wisconsin fishing and boating regulations.
- 15: No motor trolling will be permitted.
- 16: Prizes will be based on 60% of entry fees according to the following schedule:

First Prize	30% of entry fees
Second Prize	20% of entry fees
Third Prize	10% of entry fees
- 17: Places are determined by total inches of fish caught.
- 18: Minimum length of fish that will be registered is 34".
Fish are measured in 1/4" increments rounding down.
- 19: Time of registration of first team fish will be used as a tie breaker, earliest time wins.
- 20: Anyone caught cheating will be immediately disqualified and will forfeit their entry fee. The determination of cheating will be done by the tournament staff. All decisions of the tournament staff are final.
- 21: As stated above the tournament entry fee is \$100.00.
Upon receipt of this entry form and entry fee the team's flag number will be awarded.
